Child Assistance Team (CAT)

Half-year factsheet

January – June, 2026

The Child Assistance Team (CAT) is a specialised service established in 2010 within the Children's Programme of the International Centre "La Strada". The team consists of a lawyer and several psychologists who provide assistance to child victims and witnesses of sexual abuse and sexual exploitation throughout criminal proceedings.

► Our mission

The mission of the team is to ensure the protection of the rights and best interests of the child throughout the entire criminal justice process, with the aim of preventing re-victimisation and promoting the effective application of restorative justice principles.

► Our expertise

Any form of sexual violence against children, manifested through sexual abuse or sexual exploitation, falls within our scope of activity. The use of information technologies as a means of recruitment, grooming, commission of abuse or exploitation constitutes the defining element of our specialisation. We provide legal and psychological assistance to child victims or witnesses of sexual offences.

► Guiding principles



THE BEST INTERESTS OF THE CHILD

Every intervention is focused on safeguarding the child's well-being and rights.



CONFIDENTIALITY AND SAFETY

We protect the child's identity and ensure a safe environment throughout the intervention process.



PREVENTION OF RE-VICTIMISATION

We minimise the child's exposure to experiences that may intensify trauma.



CHILD PARTICIPATION

We encourage the child's participation in decisions affecting them, in a manner adapted to their age and level of understanding.



MULTIDISCIPLINARY INTERVENTION

We combine legal and psychological expertise to provide an integrated and effective response.

Feedback

Challenges identified

- ▶ **Delays in judicial proceedings** – repeated postponements of hearings prolong the child's exposure to the criminal justice process and delay access to justice and protective measures.
- ▶ **Challenges in investigating crimes committed online** – the collection of digital evidence and the identification of perpetrators remain difficult, in the context of the use of social networks and messaging applications.
- ▶ **Insufficiently adapted protection throughout the proceedings** – the lack of clear mechanisms for victims who reach adulthood during the criminal proceedings affects the continuity of protection and assistance.
